



## **WEIRTON HALL OF FAME NOMINATION FORM**

The Weirton Hall of Fame Committee is accepting nominations for former and current Weirton residents that have made or are making a “significant, outstanding achievement(s)” in the following specific areas:

**Philanthropy** – Honors individuals that have demonstrated an extraordinary and sustained commitment to improving Weirton through charitable giving, volunteerism, and social impact.

**Public Service** – Honors individuals who have made outstanding, significant government or non-profit contributions for the betterment of Weirton, WV.

**Music and Fine Arts** – Honors individuals who have made significant contributions to the cultural life of the Weirton community.

**Business, Industry, and Professions** – Honors individuals that have made significant, long-term contributions to the local economy, community development, and professional landscape of Weirton, WV.

**Education and Religion** – Honors individuals who have made significant contributions to the intellectual, moral, or spiritual life of the Weirton community.

**Sports and Athletics** – Honors individuals who have made significant contributions to the Weirton sporting community, by fostering pride and legacy.

**ELIGIBILITY:** Honoree nominations can be made for individuals with “outstanding, significant accomplishments” that have resided within the City of Weirton for a minimum of five (5) years and **HAVE DISTINGUISHED THEMSELVES FOR THE COMMUNITY SINCE THE CITY WAS INCORPORATED IN 1947 IN ONE (1) OF THE ABOVE CATEGORIES.**

Achievements prior to 1947 may be considered as part of their service to Weirton if they have remained active after the date of incorporation.

**METHOD OF NOMINATIONS:** All nominations must be submitted on the Weirton Hall of Fame nomination form by **April 1, 2026**. Each nomination must state the reason for the nomination in the form of a biography and a list of major, significant accomplishments of the nominee. Failure to provide this documentation will exclude the nominee from further consideration.

All nominations must also be signed and dated by the individual making the nominations. Nomination forms received without a signature; will not be considered. NO EXCEPTIONS.
